Attorney Frost presented the draft ordinance on cannabis regulations. The Village of Logan will establish limited restrictions on use and manufacturing of marijuana. Retail dispensaries will operate in locations that are zoned commercial. Consumption will be prohibited in a public place. The hours of operation of any cannabis retail will be limited.

Upon a motion by Councilmember Bass and seconded by Councilmember Osborn, Council unanimously approved to advertise the Cannabis Regulation Ordinance.

ITEM 7 – OLD BUSINESS – Councilmember Osborn questioned if the roads and potholes will be repaired soon. Administrator Parnell stated that they are about a month out on repairs.
